Technology and Internet are available to students at St. Margaret Mary Catholic School.

By signing this agreement, I accept and agree to abide by the St. Margaret Mary Catholic School Electronic Technologies Acceptable Use Policy. I realize that the primary purpose of using technology at St. Margaret Mary is strictly educational. I will limit my usage to educational purposes that further educational goals consistent with the mission and policies of St. Margaret Mary Catholic School.

I understand that use of school electronic technologies is a privilege, not a right. Access may be revoked at any time by St. Margaret Mary Catholic School, as it sees fit. Inappropriate use will result in suspension or cancellation of use and/or access privileges; payments for damages and repairs; discipline under other appropriate policies, including suspension, expulsion, or termination or civil or criminal liability under other applicable laws.

I will not use St. Margaret Mary Catholic School electronic technologies to engage in any behavior that is illegal, inappropriate, destructive or harmful.

I recognize that, even though the Archdiocese of New Orleans' Office of Catholic Schools uses technical means to limit student internet access, these limits do not provide a foolproof means to prevent access to all inappropriate information. It is my responsibility to avoid such information and inform my teacher immediately if I accidentally access inappropriate information.

I understand that my use of school electronic technologies is not private and that all of my activity, transmissions, documents, posts, etc. are subject to review and monitoring by St. Margaret Mary Catholic School personnel.

I release St. Margaret Mary Catholic School from any liability resulting from actions I take while using school electronic technologies including unwanted financial obligations.

St. Margaret Mary Catholic School may provide personal accounts for communication, document sharing and access to educational tools. Any access I am granted to personal accounts through the school must meet all of these criteria, or my privilege of use will be forfeited.
